Brief CV, 2016 Robert J. Nash, Professor

Robert J. Nash has been a professor in the College of Education and Social Services, University of Vermont, Burlington, for 48 years. He specializes in philosophy of education, applied ethics, higher education administration, scholarly personal narrative witing, and religion, spirituality, and education. He has graduate degrees in English, Religious Studies, Applied Ethics and Liberal Studies, and Educational Philosophy. He holds a faculty appointment in the Department of Leadership and Developmental Sciences. He is the founder, and director, of the graduate degree in Interdisciplinary Studies in Education; and he is the co-founder of the Higher Education and Student Affairs Program (HESA).

He teaches courses in educational studies, higher education administration, and interdisciplinary studies in education. He administers the Interdisciplinary Master's Program, and he teaches applied ethics, religion, higher education, and philosophy of education courses, as well as scholarly personal narrative writing seminars (a genre of writing that he created), across four graduate programs in the college. He has supervised over 100 theses and dissertations, and over 1000 final comps manuscripts. He has published more than 110 refereed articles, as well as numerous book chapters, monographs, and essay book reviews. He is a member of the editorial board for the oldest, and most prestigious, journal in its field—*The Journal of Religion & Education*. He contributes an article a year to the most-read journal in the higher education and student affairs field, *About Campus*.

In 2003, he was named an Official University Scholar in the Social Sciences and the Humanities at The University of Vermont, only the fourth faculty member in the history of the College of Education and Social Services to be so honored. In 2009, he received the Joseph Anthony Abruscato Award for Excellence in Research and Scholarship at the University of Vermont. In 2010, he was the recipient of the Gordon Fielding Lewis Award for Excellence in Teaching and Research from Pi Gamma Mu Honor Society, the largest social sciences honor society in the world. His books have won three separate Critics Choices Awards given by the American Educational Studies Association—one of the largest numbers ever awarded by this national scholarly association. Books:
