ANNUAL REPORT: Fall 2022 – Spring 2023

The Curricular Affairs Committee (CAC) of the Faculty Senate met eight times during the 2022-2023 academic year. The October meeting was cancelled due to lack of matters requiring discussion. Our September, February and May meetings were held in person and the other monthly meetings were held on Teams.

- Learned about changes to course co-locating rules from Dean Forehand
- Created a process for programs seeking to change or obtain a new course prefix in Banner

Trends noticed in the APRs in front of the CAC this year included:

- Feedback on facilities is less frequently noted by external reviewers as part of the APR discussion
- In each APR the faculty were lauded for their efforts and creativity in teaching and/or research
- Continues to be a strong need for more faculty to continue or grow programs as faculty retire or leave
- Outside reviewers are beginning to offer suggestions to support programs to function at an R1 level
- Even without an onsite visit, external reviewers engaged with the process and were able to provide programs with concrete suggestions to address issues they identified in the self-study as well as in some cases warn programs of issues looming on the horizon

The CAC chairs also met twice with leaders of the unit curriculum committees to engage in discussion around curricular trends, processes, and questions. A significant focus of our colleagues within unit curriculum committees was integration of Catamount Core and the campus wide course renumbering process (including working through challenges related to

co-location). We want to recognize their effort. CAC had a very active and productive year, and we anticipate that next year will be a busy year for the committee!
