In other matters, the PSC brought two items for Senate approval:

Review and recommendation for approving Faculty Scientist pathway in College of Medicine Resolution for campus-wide uniformity in scales (and directionality therein) used for students' evaluation of teaching

Finally, the PSC is reviewing a proposal from the College of Medicine to streamline the paperwork involved in promotion for that College's faculty members in pathways other than the tenure pathway.
