• Alternative Modes: Poultney-Rutland bus line efforts struggling Poultney and Marble Valley Regional Transit have been trying to find enough funds to create a connection between Poultney and Rutland, either for an entirely new line or one that extends an existing route. • No Idling: Middle school efforts honored

• No Idling: Burlington renews idle-free efforts

The City of Burlington has put fresh efforts into its 17-year-old anti-idling ordinance. Street signs, mayoral cheerleading, and department head support are all backing up the current education campaign. The ordinance also allows a \$45 ticket for a violation. • No Idling: State receives grant to counter schoolbus emissions The Vermont Agency of Natural Resources has received a \$194,494 grant from the EPA to install advanced pollution control equipment for more than two dozen school bus operators around the state. • Policy Watch: Vehicle emission standards lawsuit underway Vermont continues to make national headlines with the vehicle emission standards lawsuit brought by automakers finally underway in Burlington's federal courtrooms as of Tuesday.

The Federal Court case which pits the automakers against Vermont air pollution regulators is open to the public, thanks to the work of the Burlington Free Press and District Court Judge William Sessions. The case is expected to last about three weeks and takes place daily from 9-5. The Court is located on the 5th floor of the building on Pearl Street that houses the Burlington post office. • Policy Watch: Status of "gas guzzler" fee

The Vermont House Transportation Committee voted in favor of a \$150 one-time fee for new cars that get 20 miles per gallon or less in combined city and highway driving and trucks that get less than 17 miles per gallon, starting with 2009 models. If the house passes the bill, it will face other hurdles. The chair of the Senate Transportation Committee has critiqued the bill's impact on businesses, and Governor Douglas has also indicated his opposition.

The bill also includes appropriations for public transportation, a 2 cent/gallon rebate for biodiesel fuel, vehicle emissions labeling, and a 1% reduction in the purchase and use tax for vehicles that have a fuel economy of at least 30 miles per gallon in city driving. The bill (H.540) is currently being reviewed in House Ways and Means. [Source: <u>Burlington Free Press, Times Argus, Ruland Herald, VT Legislature</u>]

Vermont farmers and agricultural officials had an opportunity to weigh in on the 2007 federal Farm Bill during a U.S. Senat field hearing held in Montpelier.
