Bike & Ped: Multi-use path benefits Multi-use paths (also known as 'bike paths') not only provide alternative

mobility options, they can also become economic engines in their own right by increasing property values and attracting tourism. Burlington and Stowe each estimate that their multi-use paths bring in millions of dollars in revenue. Rutland is currently considering a two-mile multi-use path. These projects qualify for 20% match federal Transportation Enhancement (TE) funds. Vermont's 2008 grant round deadlines are coming up; letters of intent are due by May 31. - Bike & Ped: Bike path planning delay (St. Johnsbury)
 St. Johnsbury Academy has rejected access to the Three Rivers
 Transportation Path, saying that it would interfere with activities on the
 he baseball field which it would have crossed. The path has been under
 development for 15 years. The proposed reroute will include the Lamoille
 Valley Rail Trail and Western Avenue. The town's bike path municipal
 project manager has stated that the reroute should be cheaper than the if
 the path were to cross Academy property. [Source: Caledonian Record]
- Bike & Ped: "Bicycle Benefits" program (Burlington area)
 Bicycle Benefits is a year-round bicycle commuter program which rewards cyclists. You receive Bicycle Benefits by riding their bikes to participating businesses and presenting your Bicycle Benefits sticker affixed on your helmet. The sticker can be picked up at participating businesses and Local Motion. [Source: Bicycle Benefits]
- Bike & Ped: Pedestrian safety and AARP (Burlington)
 Burlington's Livable Community Project, spearheaded by the Vermont chapter of American Association of Retired Persons (AARP Vermont) is assessing the city for pedestrian trouble spots. AARP will be keeping track of their findings and submitting them to the city, with the hope that they will be incorporated into Burlington's transportation planning process.

- Alternative Modes: Rail spur proposed (Middlebury)
 A proposed rail spur in Middlebury would provide a more fuel-efficient way for businesses to transport their freight, and reduce truck traffic on Route 7 south of Middlebury. A hearing on the project's Draft Environmental Impact Statement (DEIS) is set for June 7 at 7pm in the Middlebury Municipal Building Gymnasium at 94 Main Street. The Federal Highway Administration and the Vermont Agency of Transportation will accept comments until June 29. The DEIS can be downloaded here. [Sources: Times Argus, Rutland Herald]

Policy Watch: CAFÉ standards

Federal Corporate Average Fuel Economy standards have been widely discussed in Washington over the last two weeks. President Bush called for 'reforming and modernizing" the standards for cars and extending the current light truck rule, and a U.S. Senate committee approved a bill which would raise the standard to 35 miles per gallon by 2020, up from 27.5 mpg currently. Critics of Bush's plan say that his deadline is unnecessarily far off; critics of the Senate bill point out that an 11th-hour amendment allows for a reduced standard if proposed 35 mpg average is found by the Secretary of Transportation to not be cost effective for the affected automakers.
