Resolution in Support of Equality Across America

Senator Hannaford: Read resolution. I think all this legislation that is addressed is long over due. 1974 was the first time similar non discrimination acts have been brought up. It looks like a good chance to get these through the senate this year. I feel this reflects the current feelings on campus. This something we should be letting our senators and representatives know about.

Senator Whitmore: I am in support of this but what are we hoping to accomplish through this?

Senator Hannaford: This last be it further resolved, on October 11<sup>th</sup> there was a national march over 100 thousand people came out for that and they decided in order to continue the momentum that people should brake off and start local cells. Its centered at our school. If Representative Welch and Senator Sanders received this its furthers the momentum for them.

Chair Glynne: we are saying that Obama intends to repeal this act mentioned. But the justice department is undermining the president's view. To say the president is actively supporting this I think is false because his actions say something different. It's been stated that there are more important aims than this, this was said from the military commanders who have been in combat. I don't feel comfortable as a civilian to tell them what the best thing for them so I can't support it.

Senator Hannaford: I don't think that reduces the importance of our resolution here.

Chair Maciewicz: While I respect Chair Glynne's opinion I think equality at all cost is more important than war. I think it's an appropriate reference to use Obama because he said if the bills reached his desk he would sign them. The progress that was started by this march needs to be kept up, it is critically needed because it's a fight that is not easy to win.

Senator Henley: It's important to remember that a resolution like this is symbolic, that it's important on a ground and state and university level to be drawing attention to the issue of equality. I don't exactly understand how promoting equality in the armed forces would get in the way of any other issues.

Senator Vivas: I would like to have clarified in the beginning it says 77% of bias towards them in public space. I question whether there is 77% of the campus is against transgender or if there are 77% victims.

Senator Hannaford: Campus climate survey in 2005 says 72.7% of respondents who took the survey who were transgender said they experienced a bias in public space on campus. The people who responded were made to feel uncomfortable about their identity.

Senator Vivas: So could we get to the conclusion that its not publicly accepted to be transgender?

Chair Maciewicz: It's true they don't ask you about your sexual orientation but if you are found out than you will be honorably discharged and will loose your job and all the benefits.

Senator Shushereba: You may be out if you state that you are homosexual but people also get out not because they are homosexual but stating that to get out of the military as well. So keep that in mind.

Resolution in Support of Keep Local Forms

Chair Wilkinson-Ray: Read resolution. There was some frustration in the process of how it was bought to the SGA and I had said that I was going to include something saying we were disappointed in how the administration brought it to us. Rather than put that in the resolution and complicate the matter I think it's a bigger problem the SGA needs to look at in general but I decided not to include it in this resolution.

Senator Michel: Friendly amendment to change students to consumers in the second be it resolved. (accepted)

Senator Benes: What happened to Chair Wilkinson-Ray: thinking about contributing 5 cents and us 5 cents?

Chair Wilkinson-Ray: As far as I am aware that was never planed. All Sodexho profits and incomes come form students. So we might not see a raise in milk prices because the milk prices are going down. But

that money is coming from the students anyway and they have to make a certain profit. Realistically the money is coming from the consumers which is the idea of the KLF program.

Senator McDonald: the part where it says 10 cents per unit, what does unit mean?

Chair Wilkinson-Ray: Unit is not a specific word. If you wanted to say bottle that's fine. But I said unit because they are hoping to use this in the dinning halls which uses bulk milk. And it will be the same 10 cents per volume that it is for the little plastic bottles so its 10 cents per that volume.

Chair Cafarelli: we are not in support of a 10 cent increase. We are saying we support that 10 cents of the cost of milk goes to the farmers.

Chair Wilkinson-Ray: Yes, we are saying we support a direct payment from stunts to the local dairy farms. We are not saying we support a 10 cent increase on milk at UVM because as long as those 10 cents get transferred I am not going to tell dinning services how to account for that. If the price of milk goes down the price on the label might not go up. Or they might raise the price of milk 5 cents and than orange juice 5 cents but its not our role to tell them how to price there items.

Chair Cafarelli: Are you at all worried that this will be viewed as a support of an increase in the price of milk?

Chair Wilkinson-Ray: Well I think that is one of the options so I am not gong to say we are not in support of it. We are in support in a 10 cent increase in some item that the dinning serves sells. But I am not worried about that.

Senator Buswell: Pont of info about Vermont for the past 200 plus years we have been per capital one of the highest agricultural states and we are incredibly at the mercy of the markets and I think it's important to have a more civic approach to local agriculture. It's silly to think that to produce milk it cost more than to buy it.

Chair Wilkinson-Ray: I included in this bill under the condition it will expand outside of the University. I don't want it to look like the UVM students are going to save dairy farmers. Its with the intention to take it out into the free market, we are willing to support this as long as it continues to develop because it has to be big in order for it to succeed.

Senator Altendorfer: Friendly amendment to replace the word unit to court. Because the unit size we are talking about is a court.

Chair Wilkinson-Ray: How sure are you that it's a court?

Senator Church: I think it's not a court. The larger issue here is that farmers are not getting the pay they deserve. And we talked about that when the people came in form Vermont Department of Agriculture. Really we need to be looking at the middle man. Along those lines I think I view the KLF program as a stop gap solution. It's uneconomic because it pays out money without respect to consumer preferences. I support this resolution but I would like to see UVM go in the direction of purchasing milk directly from farmers and that provides a much greater payment to the farmers. So I have some friendly amendments. A where as that explains what I just said. And a be it resolved that UVM supports Sodexho in sourcing milk directly form farms and be it resoled that they support reforming a faulty milk system.

Chair Wilkinson-Ray: I am not going to accept because I think its another resolution saying that the milk pricing system is outdated. I personally agree with you but I think it takes away from the point of the resolution and could be looked at another time. The next be it resolved do you know any farms that are equipped to supply UVM? You cannot sell raw milk in the way that UVM dinning is set up. If Vermont Milk Company was still in use than that would be logical, but there doesn't seem to be anyone equipped. I think it makes more sense to have producers to add competition to that market. But I don't see asking UVM to source all its milk from framers I don't see how that's legally possible.

Senator Church: You asked if there are farms equipped to do this. Monument farms are to my knowledge. So yes is the answer.

Senator Baron: Friendly amendments saying the word strongly contributed to the loss of 100 dairy farms.

Chair Wilkinson-Ray: I don't see any other reason that could have lead to that. Is there another phrase besides strongly contributed?

Senator Henley: Weather has influenced there hay and corn crops and then sourcing that feed for their animal form other farms, so that has contributed to the loss of some dairy farms in the pas year.

Chair Wilkinson-Ray: I accept the friendly amendment.

President Jones: Chair Rifkin wanted me to say this. Keep in mind that even if the price of milk on the label doesn't change it is still in theory a tax on some sort of product. They think that as of right now the milk will stay the same but know it is a tax on your points no mate what the prices ends up doing with this program.

Senator McDonald: Friendly amendment to the word unit a suggestion would be a single serving container or volume equivalent.

Senator Altendorfer: she is referring to a 14oz container

Chair Wilkinson-Ray: Accepted.

Senatorial Forum

Senator Baron: we voted to not pass the minutes in the beginning of the meeting because I think it's important to come across as a professional body. I think that some simple spelling mistakes make us look bad.

Senator Michel: Point of information even if the minus aren't passed they are put on line.

Senator Buswell: It was more than grammatical errors. We are doing a tabling event for next week but I have a sign up sheet for Wednesday the 11<sup>th</sup> so if you could put down any times you would have available to table put them down.

Senator Frye: I think it might not be appropriate when discussing these bills to propose fundamental changes that require time. And in the future if we feel these changes need to be made we should table the bill.

Chair Cafarelli: I strongly encourage that we stick to the structure of senatorial forum. In regards to Senator Churches potential amendments they were great but I believe that things like that should be considered in another resolution.

Chair Glynne: I voted no because I view the KLF as the university pulling a publicity stunt. In essence I see it failing because its not going to provide the necessary funds for the farmers. For elections the \$250 for advertizing I think it should be lowered because not all students can come up with that amount of money to advertise.

Senator Benes: It would be great to see some type of change in the system of the minutes where you can motion to review the minutes and then we can change the minutes if we see any changes that need to be made.

Senator Michel: Basically how I view the resolution working each whereas has a corresponding be it resolved so ultimately the resolutions are very clear without getting to general. I thinks that those pieces of legislation are easier to make sense of. So I wanted to thank Chair Wilkinson-Ray for not accepting those amendments.

Senator Church: The broader issue of KLF. The University was going to do it whether or not we put our stamp on it and how we are an advisory body not governing and another example es the academic calendar. And spires of excellence and it said role of SGA- none. What can we do about it? Is there power that we as a body would like to have?

Senator McDonald: Talk about changes that were proposed to the appointments process. As they were described to me they seem complicated. I would like to offer my own suggestion. More of a direct vote kind of thing where the Vice President decides which if those applicants comes up and I would like to see 2 applicants per seat available. And those applicants would come to the body and we can ask them questions and so on and each senator gets a number of vote per open seat and we vote for the applicants we like the best and than the applicants with the greatest number of votes get it.

Senator Buswell: The things that Senator Church bought up would have been appropriate in the resolution that was proposed but we have a simplistic way of writing them. We are not doing the kind of research Hannaford did on the previous resolution. Why another resolution if its the same issue. We should get better at writing resolutions.

Chair Wilkinson-Ray: KLF. I agree with what Senator Church brought up but being ale to add 3 paragraphs to a resolution right now especially amendments that I thought were correct and did pertain before we pass them I want to go back and research some of this stuff especially some of the amendments were bold statements. I encourage people to send suggestions like that ahead of time. As far as doing more research, I wanted to keep it clear and simple and to the point when people read it. Sometimes lots of facts just confuse people. As far as our powers, I think it makes a lot of sense for us to vote on things like the calamander because the faculty senate has the opportunity to weigh in so should the students.

President Jones: If you didn't like the process with KLF than blame me. We were asked over the summer if we wanted to have a conversation about this and we said of course we will sit down and talk about this. The plan was they wanted the SGA to have its formal say on the issue before it moved forward. But there was a communication blip but once I got on the phone with Sodexho its been cleared up and they

have been waiting for us to make our stance in support or opposition of it. If you thought that I didn't commutate enough about the process let me know.

Vice President Ash: as far as it being over compacted it does appear that way but looking at the big picture it's a very basic system in terms of more direct voting. It does come directly from the senate in that the first people to pick from the applicants are the senators. The policy is so that the Vice President can't specify pick someone because in the past there has been a very big issue because the senate is your senate and I have a problem by saying out of 25 I see 15 that I think would be great. I think that direct voting should come from the senate from the very beginning. As far as 2 people per seat. We tried it earlier this year and that had a lot of complications. However that stated if you read the statement of purpose it says that the nomination of the students to come forward for appointment is that it's believe that the student will serve as a good member to a standing committee. So the students who come up for conformation are intended to come up for conformation. So we don't have to sit here spending an extra hour questioning them because there has already been many levels they have gotten through.

Chair Burns: Chair Wilkinson-Ray you brought up that you wanted to see on the academic calendar a senate vote supporting what the faculty senate should do but the faculty senate themselves didn't know there proposal less than a week before there vote on it themselves. So I wanted to do that but insted the executive committee wrote a letter saying our support in representing the SGA and putting our support as speaking for the SGA in what we want. But it just wasn't feasible for us to vote on it.

Senator Michel: I feel like a lot of the work we do is work that's helping to better the University, but I wonder if maybe we need to redirect our efforts for working for students. A lot of the things that PR has brought up aren't necessary a function of the amount of hours spent doing work but the work isn't necessary going directly to help students.

Senator McDonald: The sub group on talking about the sustainability requirement. We met a couple Saturdays ago so if you are going to edit that please do it by Saturday. On Saturday we are having another meeting. If you have any input please bring it to me.

Senator Church: I agree we aren't necessarily doing that much to address the direct needs of the students because they don't necessarily express their desires and needs. And they may not because the SGA has no power and that is recognized. In order to make the students care I think we should look at how the SGA can function better as an organization.

**Executive Reports** 

Speaker Ellis

Are we really setting a agenda for the university and our selves or are we being the student representatives we were elected to be. We have done a lot, but I think there are more direct and actionable ways to see these things get done. I would like to see us each hold each other accountable. Legislation that has been tabled, if those pieces of legation are not appropriate to be brought up any time soon I would like them to be taken off the table and then brought back on. I understand there are a lot of projects we working on that are behind the scenes but I think it's important for us to know what each other are doing. If you have a question for the senate use senatorial forum to your advantage. I am sending out the legislation to the administration by email. If you want you legislation to be handed to them directly that's your responsibility let me know how many copies you need. November 24th we

are not having a meeting. Possibly getting a tape recorder to help the minutes taker. Chairs if you would like to sit on the constitution committee you can but I would like to see more of senate getting involved. 4:45 Friday we are going to be meeting in the office.

### Vice President Ash

We are inviting the free style ski team into the office space. There are no open spaces anymore. When you are there during your office hours I encourage you to go over and meet your peers. I want to let you know you will be getting an email by the end of the week with an update about your attachments to your USB's. Appointments: ultimately the senate does have the ultimate say. I am really open to questions. It's coming up next week for the final draft. We are implementing next week a mid semester evaluation. The executive committee had a meeting with Pat this morning and got the news that H1N1 vaccinations have arrived. There are between 500-600 doses available at this time. That means that there are going to be lots of people in the DC and this is a great opportunity for SGA to talk to UVM community members.

### **President Jones**

The general education task force is having forums for the community. The first one is November 11<sup>th</sup> from 4-5:30. The first is for faculty discussion. Next on the 16<sup>th</sup> is directly for students and then on the 23<sup>rd</sup> it's open for anyone. No one will be turned away from these sessions; we just wanted to be able to hear from all the individuals it might affect. I went to one of the sessions last week for the sustainability conference. They are working on creating a good survey. Naked bike ride is coming up, we had our fist meeting. I think it's a little late to make any significant changes. They are asking for \$5000 again this year form the SGA. I want you to really think about this. I asked the hypothetical if the SGA decide not to fund any of it than most likely the administration would use their funds to prevent the event from occurring. 2 students got GPS's in the bus systems and there is a website were you can pick your root and it shows you exactly where the bus is and you can text what root and stop and it will tell you how many minutes till it will be there based on an estimate from the GPS system. We talked about having three forums at the beginning of next semester. The idea was to hear from the students' perspective and we would invite certain individual but the hope is we can have conversations with the students. The topics would be the budget, tuition, and student rights illegal substances in residence halls/ on campus. With the budget we want to talk about what happened last semester and this semester with the \$3 million cuts. And about what's going to happen FY12. With tuition talk about background structure and past increases and show how much we are paying in comparison to other competitive universities and talk about the increases. For student rights we wanted to talk about student verses police officer rights. Talk about students' rights specifically with illegal substances. And what are the legal rights by Vermont laws that police officers have. I am going to reach out to IRA to add in the element of res life and how there polices fit into the picture. I hope to have a legal representative and police officers there. If there are other topic or ideas please pass them on to me. The comment about the SGA having no power. So first of all the other governing bodies on campus have the same enumerated abilities other than the faculty senate. So its interesting because the first thing that comes to my mind is you are not testing the system and seeing how much power the SGA has. If you construct your augment and you do your work and research you can really sway the university and the officials here. If you aren't' doing it and you want to think we have no power I want you to rethink being a senator.

Chair Wilkinson-Ray: last fall at the event I told the task force the SGA would not fund it again but we funded half of it in the spring but that was clearly stated to the task force that we would not fund it

beyond the first time which was last winter because it was an immediate cause, but there was plenty of time to think of how to run the event economically. But now there is every little time to change the make up of the event.

Chair Cafarelli: The reason why it came back last semester is we already set the precedence that it was something that had already been done this year. Based on financial policies that we only fund money to UVM recognized clubs the naked bike ride most likely will not be allocated when they come looking for money. If you have questions about why come to me before it comes up in a meeting.

Senator Benes: who is heading up those forums?

President Jones: As of now it myself and Vice President Ash and Treasurer LeMieux, but the thrid one we wanted more student presenters.

Senator Buswell: where are the general education task force meetings?

President Jones: 7:30 am in Waterman Memorial Lounge.

Senator Buswell: Where are 3 forums taking place?

President Jones: For faculty is in the carpenter auditorium. The 16th and 23rd are in billing north lunge.

**Committee Reports** 

Finance- Chair Cafarelli

Our committee had a good meeting today. A lot of clubs are in nationals so we are allocating money. We are always looking to answer any questions anyone has.

Student Activities- Senator Morgan
