IMPACTS:

- 98% moderate/considerable (4% increase) general knowledge about PPE for Pesticides
- 98% moderate/considerable (31% increase) general knowledge about Ag Container Recycling
- 98% moderate/considerable (14% increase) general knowledge about Pesticide Risk to Pollinators
- 94% moderately/very likely to apply and use pesticides more safely
- 92% moderately/very likely to adopt at least one new IPM practice
- 88% moderately/very likely to adopt at least one new IPM practice to protect pollinators

Review of the Northeast CORE Manual followed by the Vermont Pesticide Applicator CORE Exam https://www.uvm.edu/sites/default/files/UVM-Extension-Cultivating-Healthy-Communities/PSEP/PSEP_InitialCert22.pdf

IMPACTS:

- 87% moderately/well prepared (104% increase) to take the exam following the review
- 51% moderately/very likely to apply and use pesticides more safely
- 81% moderately/very likely to adopt at least one new IPM practice
- 89% moderately/very likely to adopt at least one new IPM practice to protect pollinators
- "This was a very helpful review course to prepare for the exam."
- "Because I'm so new to the industry, this meeting has been very helpful."
- "Good overview of the regulations and strategies for pest management."

Test results:

- 43 tests graded
- 4 failed
- 91% pass rate
- 100% pass rate for the Private Applicators
- Quite a few got recert credits

IMPACTS:

- 100% moderate/considerable (49% increase) general knowledge about reading pesticide labels
- 91% moderate/considerable (214% increase) general knowledge about pesticide regulations
- 100% moderate/considerable (133% increase) general knowledge about pesticide exposure and risk
- 100% moderately/very likely to apply and use pesticides more safely
- 93% moderately/very likely to adopt at least one new IPM practice

IMPACTS:

- 1574 subscribers

Biennial evaluation (Spring 2021) results:

- 92% apply and use pesticides more safely
- 56% adopt at least one new IPM practice
- "Good reminders of certain PPE considerations that applicators can become lax over time about."
- "Helps me interact more wisely with [herbicide work] contractors."
- "Reduce pesticide use through mechanical applications where possible."
- "We're paying more attention to timing of treatment."
