

Leaving Employment

3.01 (c) (2): Business entities required to obtain a company license shall: send written notice to the Secretary within 30 days whenever a certified commercial applicator is terminated from employment

3.01 (d): Certified non-commercial or commercial applicators shall send written notice to the Agency within 30 days of termination or changing employers.
