




Our Quality Framework



Current Process for Developing & Sharing Shared Plan of Care (SPoC)



Opportunity Statement and Global Aim

This project would support pilot users in developing a Shared Plan of Care (SPoC), with patients and families, within their current Electronic Health Record. PDF copies of the SPoC would be uploaded by the care team to VITLAccess where the user would categorize the document as a SPoC. Other VITLAccess users would be able to access the SPoC document within VITLAccess as needed.


Global Aim:

Anticipated Timeline







Recruitment

Ideal pilot user will be a HIPAA covered entity/care team

 Already VITL data contributor and/or data user [or are willing to complete necessary VITL agreements/training

AND

 Already working with several care team partners in developing and sharing SPoC (or other care plans)





Pilot User Roles

Upload and Label SPoC

- Medical home care coordinator or clinician creates SPoC with family
- Medical home has a need to share the SPoC with essential care team members
- Medical home uploads and labels the SPoC document in VITLAccess
- Medical home prompts other essential care team members to log in VITLAccess to view the SPoC

View and Access

- Essential care team member identified by Medical Home receives prompt
- Care team member logs into VITLAccess and locates the updated SPoC
- Views and accesses the document within VITLAccess
