

CORE Manual followed by the

CORE Exam



PROGRAM DETAILS

This program will provide review of the **Northeast CORE Manual 3rd edition** and the **Vermont pesticide regulations** necessary to understand to pass the Vermont Pesticide Applicator CORE exam. This review is NOT intended as a substitute for study of the manual and regulations.

The CORE Exam will be given after the review in the afternoon from 2-4 p.m.

No category exams will be given but can be scheduled with VAAFM for a later date. A passing score of 75% is required.

Audience

This review is for anyone in the state of Vermont who uses, supervises, recommends, or sells pesticides and/or trains Worker Protection Standard pesticide handlers/ agricultural workers including forest, nursery, or greenhouses that produce agricultural plants. Garden center employees, pest control operators, landscapers, government or municipal employees, university employees, etc. can also benefit from this review course.

Pesticide Applicators

This program will provide FOUR Vermont recertification credits. The exam is not required for those attending for credits.
