# Follow-up After a Mental Health-Related Emergency Department Visit for Vermont Youth in 2023



**Introduction**: Visits to the emergency department for mental health problems are high and have increased among youth, <sup>1</sup> thus more youth need outpatient follow-up care. Using data from the Vermont Health Care Uniform Reporting and Evaluation System (all-payer claims) database, we estimate the percentage of youth receiving follow-up after an emergency department (ED) visit for mental health concerns.<sup>2</sup>

**Sample:** In 2023, youth (6-17 years) in the ED with a mental health principal diagnosis were mostly adolescent (69%; 13-17 years), female (62%), and with Medicaid (90%) insurance.

Figure 1: Mental health-related outpatient follow-up within 7 and 30 days




#### **Key Takeaways**

## **Key Takeaways**

- 95% of youth in the ED with suicidal behaviors or ideation had outpatient mental health follow up within 30 days.
- 77% of youth in the ED with anxiety/fear related disorders had outpatient mental health follow up within 30 days.



**Summary:** In Vermont, the percentage of youth with outpatient follow-up within 7 days (70%) and 30 days (86%) after a mental health ED visit was high. Nationally, among youth 6-17 years with Medicaid, 53% and 69% had outpatient follow-up after a mental health ED visit within 7 and 30 days, respectively.<sup>3</sup> Vermont youth were most likely to receive outpatient care at designated agencies, followed by primary care.
