Public Forum

Abby Crocker Presenting on Justice Research Center

• I am Abby Crocker; I am grateful for the work Abi has done, and I am grateful for all of the service SGA does on behalf of our community. I am excited to talk about the Justice Research Center, which is a new center that has grown out of eight years of initiatives. We are leveraging the power of data to bring policymakers together to make change. We are interdisciplinary and include both qualitative and quantitative data. By having data, we create a focus to bring groups together to face complex challenges. However, data alone are not enough; we also need trust and relations, we need strong community

partnerships. The people who are impacted most need to be at the heart of solving these complex challenges. We need to recognize that there are lots of different ways of knowing, such as lived experience. We are dedicated to bringing action towards change, and we are grounded by four core objectives: growing the next generation of justice researchers, conducting research and applying research, having partners and collaborators, and intentionally breaking down silos. We want to create opportunities to come together

- We are developing a research primer, which is a shared language for people to talk about data. This makes a more inclusive space because different disciplines talk about data with different languages, and people have different comfort levels with data. We have a shared language to bring disciplines together and have a common framework for communication. We are also creating opportunities for students, faculty, staff, and community partners. There are short-term and long-term research practice partnerships. Prison research incarceration network is collaborating with a national network, expansive partnerships in UVM, Vermont, and the country. We find that partnerships are essential to advance this work. It takes a community coming together to figure out what it cares about, which is how it creates change. We operate under three core values: treasuring curiosity, acknowledging everyone is an expert at something, and trust.
- Senator Brito Del Valle: My involvement started this summer as a partnership with the FOUR office and PRIN. My experience was grounded in getting familiar with the project and our partners. I participated in a series of site visits at the correctional facility in Springfield, Vermont. We had focus groups with faculty, staff, and community partners, and talked with the Vermont Department of Corrections. We heard from people who are

Incarcerated about the problems they are facing and things that they want to change. These all allowed us to gather a well-rounded perspective. I also worked a lot on comparing restorative justice. For PRIN, we had to write reflections in which we talked about our experiences within the facilities. I also worked with the data that we gathered, and we collaborated with the individuals inside and the workers to develop a survey to measure the climate. With that data, we analyzed it and gave it to legislators and those inside the prison. This experience highlighted to me the importance of data equity, and the importance of knowing where and how we get our data and what we do with it

- **Senator Lee:** Thank you both. I have questions about how more undergrad students can get involved. And how could it be applicable to students and their careers here?
 - Response: We are looking for more student involvement. We are launching a new summer program that will be open to all students on campus across all majors.
 These are really interdisciplinary challenges. That is a funded summer fellowship.
 Over the academic year, there are research opportunities. This is a clear, tangible pathway for doing work in the community in partnership with lived experience in an actual interdisciplinary way.
- **Senator Sadiqqi:** Do you have a five year plan for PRIN or any other projects that you are thinking about?
 - Response: Prisons are the least transparent institutions in the country. This is the first of its kind to have this community-driven research partner facilities. Our goal is to grow more students and faculty who want to do research in this space. We spent time building the infrastructure of PRIN. A lot of change has happened in corrections, they have expanded paretal programs to all six prisons, new peer

- recovery services, and all of these new community programs. We want more of that and more people involved
- Senator Paquette: This topic is extremely interesting to me. I was wondering if you guys
 had any connection to the political world, whether that be state or local government.
 These policies are hard to change without a bigger force to enact them
 - o It has gotta be research for action, so you need partnerships with people who can take that action. State and local advisors and the committee advisory board have been instrumental in making tangible change at the state level.

Riley Foye Presenting on Catamounts Against Cancer

- I am the President of Catamounts Against Cancer, and we raise money for ACS. We raise thousands of dollars to provide treatments for people undergoing cancer and money for cancer research. We have raised over \$140,000 in the past 3 years. Our main event is Relay for Life, which is a long event on the Andrew Harris Commons from 12 6 pm on November 8 to fundraise for ACS. We are coming together with our common experience and loss. Clubs and organizations also come, such as dance groups, bands, and fraternities. At the Relay for Life event, we have raffles, donated food, and the giant purple chair. We also do Quesidilla Night and candy grams around Halloween and Valentine's Day. We also go to the Hope Lodge, where those undergoing cancer treatment can go. We volunteer and bring dinner. Another event is where we bring in barbers to shave your head or cut off 8 inches of hair to make into a wig for children.
- SGA should come to the Relay for Life event. They can table. To come you have to pay 25 dollars, and then get a free t-shirt, Signing up for the event is your donation to ACS.

- Chair Demeo: You did an outstanding job presenting, and you guys do amazing work
- Senator Lee: Do you guys collaborate with Rallython
 - **o Response:** We usually try to go to each other's events and collaborate, but we fundraise for different organizations
- **President Connors:** Thank you so much for coming in. Other than the main events, what are other ways for SGA to become involved?
 - o Response: We have an email list you can join and a weekly meeting at 7 pm in Jeffords on Wednesday. You guys are welcome to come to any of our events. We are always looking for people to fundraise, so you guys could come to Relay and bring an event to fundraise.

Ward 6 City Councillor

- The next city council meeting is Tuesday, October 21, and we are taking up a bill that has to do with the relationship between UVM, the city, and the housing code. We have heard through formal reports that the dorms are not aligned with housing code, with issues such as forced triples, mold, mildew, and silverfish infestations. The University should be up to code, and we have asked for documentation for self-certification, but we haven't found anything from the city or the University, which is concerning. The resolution on the 21st asks the University to produce this documentation. We would love to hear about experiences living in the dorms and any reports you have or haven't made.
- Senator Campbell: This city council meeting has to be on Tuesday, so we are asking you to be okay to miss a part of your committee meeting to come to City Hall or join online. It would be very meaningful

- Chair Laychak: is there a way to review the resolution
 - **Response:** The bill should be out by the end of the day on Thursday. I can give you the link if you give us your email
- Senator Hollner: Let's say that Mercy Hall was covered in mold, what would you do about that?
 - **o Response:** The most helpful thing from our perspective is for students to report it directly to code enforcement. Be specific with photos and timelines. A lot of times, we don't even have it on paper, which means we can't do much
- **Senator Orik:** What are we giving our email for? Is there a way you guys can give us your contact info?
 - **o** Response: I'll send our contact info in the Group Me
- President Connors: President Connors: Following the Mercy Hall example, if it was
 discovered that there was mold in one of the residence halls, would you displace all of the
 residents?
 - cases Response: It is very case by case. Landlords have to demonstrate that they are taking reasonable action. Hard to give a definite answer, but they wouldn't be off the hook just for trying. The intent of the resolution is to give a last chance to the university to show that they are making a good faith effort to comply with the housing code. The city can't spend the resources to check the dorms, and the University is not holding up its end of the deal. We want to hire new inspectors and go in and treat the dorms as other apartment buildings, where we take you to court if you're not following the rules

- **Senator Camacho**: Have you had meetings with Reslife? There is a kitchen and we have been in contact with the University, but they have refused to change it because it is too expensive
 - o It's insane because that standard would never hold for an apartment. We would never expect that situation, but it is happening in the University. A lot of local government are shrugging their shoulders. The University is not within the local ordinance, so we have to force their hand. When Bernie was mayor, he took an aggressive stance against developers and the university. Bernie came in, he threatened eminent domain to private developers in order to force their hand.
- Senator Alarafi: The form you suggested students should fill out. Should we be promoting it? Do students not know about it?
 - The student tenant union was pushing for students to report, as it is underutilized by students versus the actual number of issues. There are only a few dozen reports a year. Anything and everything we can do to promote to put political pressure on the University through pressuring the bureaucrats with hard data.
- **Senator Chen**: Is this a UVM-specific issue, or are other colleges in the area facing the same issue?
 - I am most familiar with UVM. We haven't asked for info regarding
 Champlain. They have been generally better around working with the city
 proactively on housing things
- Chair Demeo: Back to the political side of things, is there a broad political will to take on this issue?

o I think there is more political will than there has been. There has never really been a conversation since I have been involved about expanding code enforcement to this degree. If people feel that students make up a large number of the population, there will be built-in pressure if students are organized through elections

 made it more accessible for students to donate. We get clothes throughout the
 semester. Adults have also been donating.
- Right now, we are becoming a club so we can officially do things. We need space for storage because we don't have a place to store the clothes
- **Senator Ranallo:** What do you do with the money?
 - Response: It is a nonprofit, the money will go back into the project, we are
 hoping for a permanent store like Ski and Snowboard, we are hoping it is
 sustainable enough that it lasts after we graduate
