"Energy Paradox, Finite Economic Life, and Energy Saving Technology Diffusion" (Writing Results). Co-Author(s): Chiang, Kevin

The timing option, utilised in the so-called "energy paradox" literature, has been a rationale in explaining why energy saving technologies tend to diffuse slowly. The current study relaxes a prevalent, yet strong assumption of infinite life for energy saving projects and products. In doing so, we introduce a new variable of economic life into this literature, highlighting the limitations of the existing capital budgeting framework and emphasising the economic implications of project/product durability. In addition, we argue that the creation and retention of a timing option has incremental costs, such as delayed benefits and switching costs, and that this further limits how effectively the timing option rationale can explain energy paradox.

The technology of REITs is an effective way to promote environmental sustainability and ethics.

"Partial Sales of Lumpy Assets" (Writing Results). Co-Author(s): Chiang, Kevin, Crocker Liu (Cornell University)
We study the pricing of partial interests in lumpy assets. Ex-ante, it is unclear what a fraction of a lumpy asset is worth due to countervailing factors which include private benefits of control, asymmetrical information, condition of sales, and illiquidity among others. We find that while a price premium exists when either a majority interest or minority interest is purchased, partnership buyouts are fairly priced while a price discount occurs if a 50% co-control interest is acquired. We also document a statistically significant price premium when a new outside buyer purchases a partial interest. In contrast, if an existing partner buys out another partner then the partnership interest is fairly priced. In addition, the sale price of a partial interest is found to be positively related to time-varying liquidity. Moreover, the sale of a partial interest on a distressed office property is associated with a greater price premium compared to a partial sale of a non-distressed property

"To Tax-Effect or Not to Tax-Effect? A Unified Framework for Valuing Pass-Through Businesses" (Writing Results). Co-Author(s): Chiang, Kevin
The debate on business valuation for pass-through entities has traditionally been fixated on whether or how to tax-effect at the business level. Regardless of whether to tax-effect or not to tax-effect, the existent valuation approaches differ in their treatments of corporate income tax rates and, thus, the resulting cash flows. In this study, we propose a general, unified valuation framework in which the existent valuation approaches are encompassed within—as special cases. Moreover, the proposed framework does not introduce *ad hoc* adjustments to pro forma statements on corporate income tax rates and cash flows, and has additional strength of using an intuitive adjustment of discount rate to account for differential taxation at the personal level between C corporations and pass-through businesses.
