4-H State Communications Day Fashion Revue: Clothing Sewn Participant Rules and Information

BEGINNER AND JUNIOR PARTICIPANT REQUIREMENTS (for State Communications Day and Eastern States (The Big E))

- 8 to 10 years old by January 1 of the current year.
- Must use commercial pattern(s), with alterations allowed.
- Must be evaluated with a blue ribbon at county or regional level.
- Can attend with a single garment, such as a skirt or blouse.
- Garment must have been constructed within the current 4-H year.
- The garment entry will be evaluated both on AND off the model at Regional Communications Day. It will NOT be re-evaluated at State Communications Day.
- Eligible for Eastern States.

ADVANCED JUNIOR AND SENIOR PARTICIPANTS (for State Communications Day and Eastern States (The Big E))

- Age 11 or more by January 1 of the current year.
- Must be evaluated with a blue ribbon at a county or regional level.
- Garment must have been constructed within the current 4-H year.
- The garment entry will be evaluated both on AND off the model at Regional Communications Day. It will NOT be re-evaluated at State Communications Day.
- Complete outfits will be eligible for Eastern States (a complete outfit covers the body; such as a dress, skirt and blouse, shirt and pants, suit, slacks and top, full-length coat, pajamas or nightgown). A single garment may be considered if it incorporates advanced techniques such as tailoring, extensive alterations, or an original design.
- Participants selected for the 4-H State Communications Day Fashion Revue must participate in the Fashion Revue rehearsal as scheduled. To be eligible for Eastern States, attendance at the current year's 4-H State Communications Day is required, unless excused with permission from the State 4-H Clothing Committee.
- 4-H members can participate in Fashion Revue at State Communications Day if they constructed/designed a garment for another person (which can be either a 4-H'er or non 4-H'er) and wish to walk as a team (designer and model). However, the team is not eligible for participation at Eastern States.
