SUMMARY OF PROFESSIONAL ACTIVITIES- OVERALL

In my current role I serve as UVM Health Network's Division Chief of Dental Medicine in the Department of Family Medicine, Program Director for UVMMC's General Practice Residency, and Clinical Site Leader of the Dental and Oral Health Center. I continue to practice dentistry in the outpatient and inpatient setting. During my time as UVMMC's General Practice Residency Program Director I have succeeded in growing the program both in size and scope. I lead and am responsible for recruitment and successfully matching resident cohorts. I have led and implemented the development of an operative service to provide dentistry to special needs patients in the operating room. Through collaboration with other services, I have expanded the availability of in-patient dental services provided at UVMMC. I have fostered relationships with community dentists leading to the addition of community clinical rotations to the program allowing for the approval and addition of a fifth resident to our program in 2024. I continually built upon the residency curriculum and most recently added a digital dentistry component to the curriculum by obtaining a Cone Beam Computed Tomography (CBCT) and digital scanner. The introduction of this technology to the program better prepares our residents as it aligns with the movement of dental practice in the private practice sector and aids in delivering high end care to patients. As the Division Chief of Dentistry in the Department of Family Medicine I oversee all network dental sites and am involved in the recruitment and retention of staff dentists. I am also responsible for credentialing and privileging of all general dentists and specialists across the network. Additionally, I was recently nominated and selected as a site visit chair by the Commission on Dental Accreditation, where I perform program reviews and accreditation visits nationwide.

Prior to my time at UVMMC I spent my career working as a public health dentist in a Federally Qualified Health Center in both Albany and Schenectady, NY. In Schenectady I acted as the Chief Dental Officer and Assistant Program Director for an Advanced Dental Education program through NYU-Lutheran Medical Center. I was also active in state- and nation-wide programs through the New York State Department of Health and the National Network for Oral Health Access.

SUMMARY OF SERVICE ACTIVITIES

Early on in my career I identified the importance of service to my profession and my community through my work in dentistry. With an interest in special care dental needs I began volunteering with the Special Olympics. I trained to be a clinical leader for the Special smiles branch of Special Olympics New York. I organized and operated the dental screenings program locally performing hundreds of dental screenings on athletes. With this experience in mind, I began volunteering my time to treating special needs patients in the operating room at St. Peter’s Hospital. This service aligned with my interest in dental education as it was an opportunity for one-on-one mentorship of dental residents in the operating room setting. Most recently, my professional service has been through organized dentistry. On a national scale I am a member of the American Dental Association (ADA). I have sat on both the Visionary Task Force and the reference committee for Dental Education and Licensure. I serve as a delegate for the house of the ADA. Locally I have been on the executive board of the Vermont State Dental Society (VSIDS) since 2020 in multiple capacities. First as the director, president

– elect, president and now treasurer. As president I had an integral role in conceptualizing and executing plans to bring a dental school clinic site to Vermont. This involved budgeting exercises, real estate searches, reviewing and meeting CODA standards for undergraduate dental education, and fundraising and grant writing efforts. I was able to work directly with Dean Mert Aksu from Detroit Mercy and Senator Bernie Sanders to work on funding streams and operationalizing this extremely important workforce project. With my assistance, Detroit Mercy-Vermont successfully passed initial CODA accreditation, and has recruited its first class, which will start in Vermont in the summer of 2027. Through VSIDS my other service projects have focused heavily on the dental workforce shortage including licensure portability, multiple paths to licensure, and dental hygiene education reform. In support of these issues, I have written letters of support to local media outlets and our government representatives, including both local and state delegations. I have been successful in writing and passing a new licensure regulation in Vermont that allows dentists to be licensed by residency, which is a large legislative change for our state. Most recently, I have been named Network Division Chief for Dentistry at the University of Vermont Health Network. In this role I have grown the network dental footprint including expanding programs, services, and improving access for our Medicaid and underinsured population. I have also taken on a network clinic in Malone, NY that is growing and expanding network services to the North Country of New York.

SUMMARY OF TEACHING ACTIVITIES

Chairside Teaching: In my role as attending faculty at our residency program, I am one of the main clinical instructors and preceptors for our resident cohorts. This involves both inpatient hospital dentistry and outpatient general dentistry in our dental clinic.

Curriculum Development: As program director for our General Practice Residency, I am responsible for development and assessment of our residency curriculum through CODA standards. I led and implemented a complement change, and major revision to the UVMMC residency curriculum and program. I have also developed a project ECHO curriculum on Opioid use in dentistry, and for our residents to be AHEC scholars.

Classroom Teaching: I am the regularly scheduled lecturer in the LCOM Family medicine clerkship week where I give a dentistry 101 lecture to third year medical students. As the residency director, I facilitate weekly journal clubs, quarterly treatment planning sessions and give several lectures throughout the residency year. I create and oversee all curriculum for the yearlong dental residency program, ensuring that all CODA standards are met.

Informal Teaching: I present each year at our dental faculty retreat on a wide variety of topics pertaining to feedback, curriculum, and overall residency education. As site leader, I am also responsible for teaching and mentoring dental auxiliaries (dental assistants and dental hygienists). In this role I continuously give clinical updates and lessons at staff meetings, clinically train new employees, and mentor dental assisting students.

Advising and mentorship: I have mentored and advised numerous medical students, undergraduate students, and past residents into their new positions as dentists, with a focus on clinical education and Operative dentistry in the hospital setting. I have directly mentored over 30 residents in my time at UVMMC, and almost 50 in my overall career.

Quality Improvement and Patient Safety Activities

I took part in managing the Periodontal Tracking project at the dental clinic to manage and organize activities in making sure all our patients were on proper recall schedules and that they were being treated appropriately. I also developed and implemented a new project to track and make sure we are recording a Caries Risk Assessment for all our patients. This can hopefully help manage our diseased patients better and appropriately. This year we implemented a process to track treatment plans and finances to be sure that both patients are aware of what we are planning and that they understand the costs involved before they get in the chair. We also added a workflow to track daily production for thoroughness of oversight and so the residents can see what their normal production is. In 2022 we began transitioning our chart review program to include resident peer reviews. I believe this will help them understand what is necessary and compare their chart notes to their peers. Finally, I have begun a retrospective study of medically complex patients seen in the OR for preoperative dental extractions to verify and track outcomes of care. The goal is to determine if preoperative dental care is effective and compare it to accepted literature.

SUMMARY OF SCHOLARLY ACTIVITIES

I am a local content expert on dental accreditation, clinical education, and paths to licensure. I have published a manuscript relating to licensure by residency and have presented locally on these areas of expertise. I have presented regionally and locally on topics such as updates on MRONJ and bisphosphonate therapy, Geriatric dentistry, and dental issues in primary care practices. I facilitate a weekly journal club with our residents, which requires critical literature review and group discussion. This focuses on being able to critically appraise literature to practice in an evidence-based manner. I serve as a local expert on dental licensure to the state dental society. I have also given testimony on statutes and regulations which involved presenting research and literature on multiple paths to licensure to both the Vermont Board of Dental Examiners and the Office of Professional Regulation.
