INSTRUCTION FOR COMPLETING YOUR POULTRY APPROVAL FORMS

This form is to be used for any poultry species. Use one form per species and submit a new form every calendar year.

1. Enter your name and full mailing address. Include a phone number where we can reach you.
2. Enter your age as of January 1 of this year and enter your date of birth.
3. Include your county of 4-H club membership and the name of your club. Enter independent if you are not in a club.
4. Make sure your leader signs and dates the form.
5. Enter the species of your bird (duck, chicken etc.). Use one form per species.
6. Breed: Enter the breed of the bird (Plymouth Rock etc.)
7. Color: Enter the color of the bird (Red Pyle, Silver- Laced etc.) Describe the bird if the mature color is not known at this time.
8. Bird's hatching date the day/month/year of each bird's birth. This determines the class you show your bird in.
9. Sex: indicate hen, cockerel/drake/tom etc.
10. Indicate age of bird when you acquired it: Hatched (it was yours when it came out of the egg), Day-Old (it was yours in the first several weeks of its life), Pullet or Older (it was yours when it had its adult plumage).
11. Leg Band Number.
12. If the leg band falls off or is missing, replace it and let your county Educator know if the number has changed.
13. Date of ownership or date lease/loan went into effect. Include day/month/year. Various events require ownership/lease/loan by a certain date. If owned, write owned and the date you own it by and if leased, write leased and the day the lease started.
14. A copy of the lease/loan form must be submitted with the approval form. Both are due July 1st in your County Educator's office.
15. Sharing of birds between 4-H members is not allowed.
16. Approval forms are necessary for participation in all 4-H Events and classes. Questions on who must complete approval forms should be directed to your County Educator. Your forms should be sent to the following UVM Extension office:
