


#331A & #331B are about 1 meter apart.

Matt of bog is CINN hummocks







#331B <sup>Sample</sup> has some fire scars (removed), One live. Might be some contamination. Most fossils are nearly fully-rotted, and few to begin with.

#331A - Fossils not especially abundant, those present mainly small wood chips, hem bark?, & "charred" TB wood?

Both pits have a piece of wood <sup>sampld</sup> each from an undetermined depth, Not the pit bottom.

① The beaver meadow with dead scattered hemlocks, has peat up to 4 ft deep, as probed with a Davis sampler with rod. Definitely return here & sample this with Eijkelkamp in 2006! Done 6/10/06

② The wetland just SW of Biscuit Brook Trailhead is on Frost Valley Property. A quick set of probes shows shallow to mineral substrate, mostly 4 to 8". In the future, ask when out a day at Frost Valley, to probe this further for any deeper peat spots for sampling.

Gaultheria procumbens along Mogaup Pond on trail  
CB at trail register in Sub-PM-B forest,  
Boreal ground cover dominants - S, LL, OX, some DF
