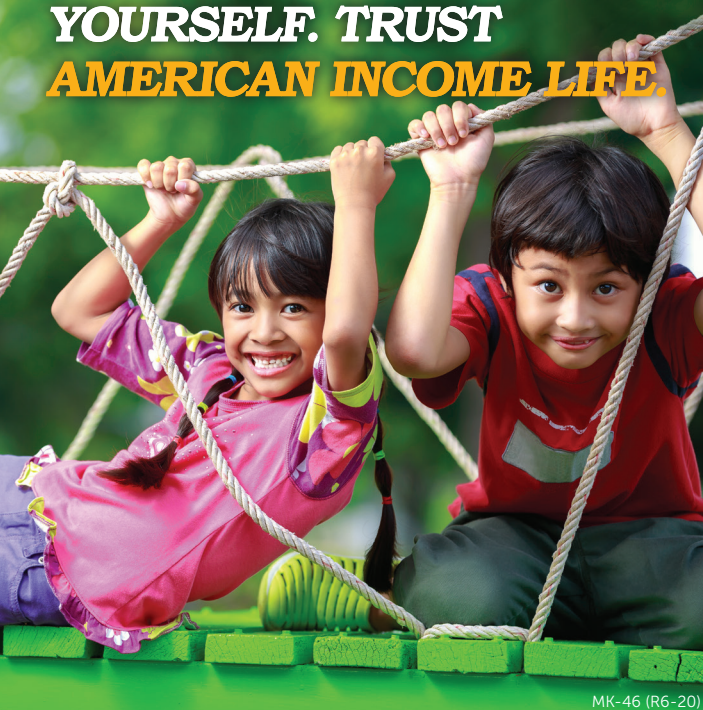

POLICY HIGHLIGHTS

- Covers any 4-H or extension sponsored activity for youth or adults
- Coverage starts for as little as \$.20 per person per day with a very affordable \$8 minimum per event
- Online application allows for quick confirmation of coverage.
- Covered accidents can receive payment for incurred medical and surgical treatment, X-rays, hospital confinement, ambulance expense, loss of limbs, dental services, and death benefits up to the maximum amount
- Covered illnesses can receive payment for medical and hospital expenses (up to the maximum benefit) while this policy is in force
- There is no network of providers – choose your physician, clinic, or medical facility
- Average claims payment: 10-14 business days

Youth, volunteer leaders, and adults participating in an adult supervised group activity sponsored by Extension are eligible for Special Activities Coverage for Accident or Illness provided by Policy Number 718 AIL Blanket Benefits Trust, Wilmington, Delaware, SentryCorp, LLC, Trustee.

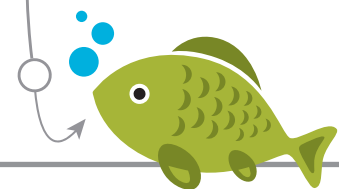
WHAT?

Everything from 4-H day camps to farm tours to nutrition classes for seniors can be covered under these policies and the benefits can be provided to youth and adult participants, volunteers, parents, or others who are assisting with the program implementation.

Policies are available for as little as \$.20 per person per day and there is *no upfront cost*. **Staff or volunteers can submit a simple online application** based on the estimated number of attendees and receive fast confirmation of coverage, with premiums to be paid after the event based on actual participation.

WHY?
