## Schedule:

- 7:30 a.m. to 9:15 a. m. Animals arrive – vet check and document check as animal is unloaded.\*
- 10:00 a.m. to 12 noon Fitting and Show Classes (Seniors first)
- 12:00 p.m.–12:30 p.m. Potluck Lunch (time is tentative): *Please your own drink AND a salad, side dish, or dessert to share. Hamburgers and hotdogs will be provided*
- 12:30 p.m. Continuation of show followed by clean-up and then departure

\*All animals will be inspected by the veterinarian and approval forms and health documents will be checked when they are unloaded. Please be certain that 4-H approval and health forms are transported with the animal. Health forms must include proof of rabies *and* shipping fever vaccination. Having the proper paperwork is the *responsibility of the 4-H member not the leader.* Any individual who does not comply with these rules may be asked to leave the grounds immediately and will not be allowed to show. The decisions of the veterinarian and University of Vermont staff are final. Animal's ears and ear tags should be clean upon arrival so ear tags are easier to read.

- Participants must bring feed and bedding for their animals.
- Registration forms (see next page) and the signed release form (see the third page) must be in the Burlington 4-H office by **Monday July 1<sup>st</sup>** (mail to *UVM Ext. Multi Co. Dairy Show, 140 Kennedy Dr. Suite 201, S. Burlington, VT 05403* or send a scan via e-mail to [rosemarie.garritano@uvm.edu](mailto:rosemarie.garritano@uvm.edu) ). Mail them well before the due date! Entry fee of \$5.00 per entered animal will be collected at the show. *Do NOT mail payment.*
- Substitute project animals with required paperwork may be brought. Note: one animal per member per class.
- Wash your animal(s) prior to arriving to help avoid congestion at the wash rack. Space there is limited.
- Judging is to be based on the Purebred Dairy Cattle Association's scorecards for Fitting and Showmanship ( <http://fyi.uwex.edu/fldairyouth/files/2014/05/PDCA-Showmanship-Scorecard.pdf> ) and Conformation ( <https://www.uvm.edu/sites/default/files/4-H-and-Youth/projects/dairy-pdca-card.pdf> )
- Bare feet, dogs, or other pets are not permitted at the show.

# Multi County 4-H Dairy Show Risk and Release Form



I, \_\_\_\_\_ as parent/guardian with legal responsibility for this participant, give permission for \_\_\_\_\_ to participate in the 4-H Multi County Dairy Show. I understand that participation may involve certain risks of physical activity and that UVM will provide each participant with due care, but that UVM cannot insure that the participant will remain free of injury. I nonetheless wish to have the participant participate in the UVM 4-H Program and voluntarily assume full responsibility for any risks of loss, property damage or personal injury that may be sustained by the participant, or any loss or damage to property owned by the participant, as a result of participating in the UVM 4-H Program. I, for myself, my heirs, assigns and next of kin, agree to: (i) covenant not to sue UVM and its trustees, employees or agents and indemnify and hold harmless UVM, and its trustees, employees and agents from any and all losses, penalties, damages, settlements, costs or other expenses or liabilities arising out of the participant's participation in the UVM 4-H Program; and (ii) release, waive, and discharge UVM and its trustees, employees and agents, from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage or injury that may be sustained by the participant, or to any property or belongings of the participant, while participating in the UVM 4-H Program. This release, however, is not intended to release UVM from causes of action arising out of the sole negligence of UVM, its trustees, employees or agents. UVM reserves the right to dismiss a participant if in their view, the participant poses a significant safety risk to himself/herself and/or others. I have read this Release of Liability, fully understand its terms, understand that I have given up substantial rights by signing it and sign it freely and voluntarily without any inducement.

I understand that showing, leading and working with dairy cattle of any age involves risk of personal injury.
