• What is Agritourism?

- Merriam-Webster Dictionary- : the practice of touring agricultural areas to see farms and often to participate in farm activities. https://www.merriam-webster.com/dictionary/agritourism
- New Hampshire defines, Agritourism is defined as "attracting visitors to a farm to attend events and activities that are accessory uses to the primary farm operation, including, but not limited to, eating a meal, making overnight stays, enjoyment of the farm environment, education about farm operations, or active involvement in the activity of the farm." RSA 21:34-a, II(b)(5).
- Maine defines it Agritourism activity. "Agritourism activity" means any agricultural activity carried out on a farm or ranch that members of the general public are allowed to view or participate in, including farming, ranching, historical and cultural activities, harvest-your own activities and attractions related to farming or ranching. An activity is an agritourism activity whether or not the participant pays to view or participate in the

AGRITOURISM

• My definition of Agritourism

Any activity on the farm that invites the public to come to your farm.

- "Agritourism" Defined by the National Agricultural Law Center
- Simply stated, agritourism could be thought of as the crossroads of tourism and agriculture. Stated more technically, agritourism can be defined as a form of commercial enterprise that links agricultural production and/or processing with tourism in order to attract visitors onto a farm, ranch, or other agricultural business for the purposes of entertaining and/or educating the visitors and generating income for the farm, ranch, or business owner.
- Regardless of the exact definition or terminology, any definition of Agritourism should include the following four factors:
- • combines the essential elements of the tourism and agriculture industries;
- • attracts members of the public to visit agricultural operations;
- • is designed to increase farm income; and
- • provides recreation, entertainment, and/or educational experiences to visitors.

LIABILITYTYPES

- Business/Farm Insurance-General Policy term
 - Insurance policy for the active farm, can include property liability, building coverage, product liability, equipment liability, operations liability, pollution liability, general liability, and more.
- General Liability, also called Product Liability
 - Products if grown, raised, made or bought for resale need liability. Just because you
 grow apples, doesn't mean your farm is insured to sell apple pie.
- Farm Pollution Liability, can be included but most states it is an extra.
- Liquor Liability
 - Liquor is very different in each state.
- Event Liability
 - Number of people, activity, facility, workers, alcohol, etc all impact the policy
