

Course Schedule Required for Completion of Communication Sciences MS Program: 2020-2021

Students must have completed all pre-requisite courses prior to the start of graduate course work in CSD. Comparable courses taken at the UG level, through CDE, or at another institution may not need to be repeated and may make room for elective courses. (See electives.) Students are required to enroll in Clinical Study, CSD 321-326, for each semester they are active in the program. In total, 48-56 credits of graduate coursework are required for the non-thesis track and 51-59 credits of graduate coursework for students who write a thesis. Equivalent graduate level coursework may be used to waive up to a maximum of nine credits, if approved by the graduate program coordinator, reducing the total number of in-residence credits needed for completion of the program.
