The Geography Department analyzes student evaluations of instructors. Results are reported on a five point scale, with 5 as the top score. My mean teaching evaluation scores for large lecture and introductory courses on a number of indicators have ranged from 3.5-5.0. For mid-sized, intermediate courses, my mean evaluation scores range from 4.3-4.9, and in advanced seminar courses the range has been 4.2-5.0.
