Co-Chair Helen Read called the meeting to order at 9:00 am via Microsoft Teams.

- 1. **Minutes.** The minutes of February 2021 were approved as written.
- 2. **Math Readiness Test.** Helen took the Math Readiness Test over in 2011 and moved it to an online homework based platform called Webassign. They have been able to use this for no charge, and Helen is able to hand pick the questions and they do not need to be multiple choice. The platform was bought out and starting April 15^{th.} UVM will be charged for the service. All incoming first year students are required to take the test. They start in May and continue throughout the summer. There are requests other times of the year also. About 2,700 students take the math readiness test per year. A small committee will be meeting to come up with a solution for the immediate future. For a long term solution they will need to look out to see what is available and potentially pilot it this summer. After they meet they will update the ERTC with any action items they may have that came from the meeting.
- 3. **Learning Management System RFP, Wendy Berenback.** This project is scheduled to go through the fall of 2023.

The success of this RFP depends on the involvement of campus stakeholders. This website will be updated regularly with information about when and how to participate in the process. One method is to share comments using **this survey**.

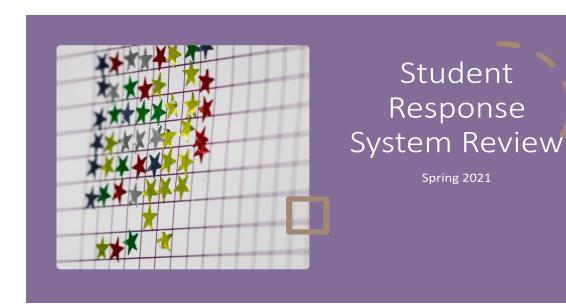
Timeline

Fall 2021	Evaluate vendor responses Host LMS demos Invite stakeholders to submit feedback Analyze stakeholder feedback Make recommendation to the CIO and Provost
Spring 2022	LMS decision
Summer 2022 – Summer 2023	Transition period (if a different LMS is selected)
Fall 2023	If a different LMS is selected, all courses will be on the new LMS
