1. For the purposes of this agreement, unless otherwise specified for a particular mare, the breeding season shall begin March 15 and close July 15 of the year on this agreement.
2. In addition to all booking, stud and collection fees listed on the Stallion Booking Contract, a \$75 shipping fee must be paid prior to each shipment.
3. Collection days are Monday, Wednesday, and Friday. No exceptions will be made. To guarantee, shipping, mare owner, or agent, must give **at least** 24-hour notice of their need for semen shipment. Please arrange to have mares checked on Sunday, Tuesday, and Thursday to schedule shipments accordingly. Please call 802-388-2011 or email uvmorgan@uvm.edu to arrange a shipment.

4. The Mare Owner certifies that the Designated Veterinarian practices reproduction as a regular part of his/her practice and is available for palpation, cultures, A.I., and other necessary procedures, and has consented to oversee the breeding of Said Mare on a regular basis. Mare Owner understands the Veterinarian’s credentials, as stated above, must be approved by the Stallion Owner and that *this Designated Veterinarian agrees to the following conditions:*
- a) Will examine Mare within 45 days prior to semen shipment and certify in writing that the Mare is free of infection and is in good breeding condition.
 - b) The provisions of a) and b) must be repeated for any Mare failing to settle within two cycles after shipment of semen has commenced.
 - c) Will examine Said Mare for pregnancy 14-18 days after the last insemination and mail/fax results to the Stallion Owner.
 - d) Failure to conform to the above will nullify all guarantees and no further semen will be shipped.
