Notice of Representation Election

The Vermont Labor Relations Board ("Board") will conduct a representation election by secret ballot, pursuant to the February 20, 2024, Order of the Board, among the following employees of the University of Vermont:

All full-time and regular part-time graduate teaching assistants, graduate research assistants, graduate assistants, and pre-doctoral trainees, pre-doctoral trainees/fellows, and all other graduate students in other titles employed in an academic position.

The employees voting in the election will be asked the following two questions: 1) whether they wish to be in the collective bargaining unit consisting of the above-described employees; and 2) whether they wish to be represented for exclusive bargaining purposes by the United Auto Workers, Local 2322.

The election will take place over two days, March 26, 2024, from 9:00 a.m. until 3:00 p.m., and March 27, 2024, from 9:00 a.m. until 3:00 p.m., at the Davis Center, Chikago Landing (second floor directly across from the entrance to Davis Marketplace), 590 Main Street, Burlington, Vermont, 05401.

Provision for Absentee Ballots

Any eligible voter who will not be present at the time and place set for the election may secure an absentee ballot by making a written request to the Board, setting forth the reason why they will be unable to cast a ballot at the designated times. The eligible voter may email their request to Judith.Dillon@vermont.gov, or VLRB.Info@vermont.gov, or deliver it to the Vermont Labor Relations Board at 6 Baldwin Street, Suite 307, in Montpelier, Vermont 05633-6101. Ballots must be received at the Vermont Labor Relations Board no later than the close of business, 4:30 p.m., on March 25, 2024. If the majority of votes cast on Question 1 respond "yes," then the results of Question 2 on the ballots will be tallied to determine whether the employees wish to be represented by the United Auto Workers, Local 2322.
