### **FUNDING UPDATES FOR VERMONT FARMS**

You can influence how 2027 Vermont Natural Resources Conservation Service (NRCS) Environmental Quality Incentive Program (EQIP) funds are spent through the Locally Led Conservation process! NRCS and the conservation districts are separate organizations that work together to address conservation across agricultural and natural landscapes. Conservation districts across Vermont gather input from communities on how EQIP funding should be spent on priority resource concerns within that district.

Example EQIP practices on vegetable farms are cover crops for addressing soil erosion and high tunnels for addressing plant health. Farms may be familiar with the conservation work of their district (e.g. riparian plantings, tree sales, public workshops), but not the local EQIP fund pool. ## **2026 INITIAL PESTICIDE APPLICATOR CERTIFICATION MEETINGS**

This is for anyone who uses, supervises, recommends, or sells pesticides and/or trains Worker Protection Standard pesticide handlers/agricultural workers in Vermont. The fee is \$50; after April 1, \$70. No walk-ins. The Vermont Pesticide Applicator Core Exam for new applicators will be offered, after a review of the Northeast Core Manual and inserts. To pass the test you need to purchase and read the [core manual](#) (\$49) and download the free “[required inserts for study](#)” in advance of the meeting.
